WHAT'S NEW FOR 2023:

Our city has evolved, and so has the Comprehensive Plan. This year's update delves into the achievements and progress of the past six years. We're updating Table 14-3 which tracks the actions that our different City's departments committed to in 2017, while also integrating fresh policies and actions from other City reports and studies that have been created since the adoption of the Comprehensive Plan

EMBRACING OUR GROWTH:

Vision Zero in Albuquerque is a dedicated commitment to foster safe, inclusive, and equitable mobility, striving to eliminate all traffic fatalities and severe injuries. Vision Zero uses a data-driven and safe systems approach to create safer streets for everyone - whether we're walking, biking, driving, or taking transit, regardless of age or ability.



The Albuquerque Climate Action Plan, a result of extensive collaboration between community members, experts, and policy advocates, the plan addresses the urgent climate crisis by harnessing the collective wisdom of Albuquerque's diverse population. The plan offers a comprehensive roadmap with policy recommendations to create a sustainable, climate-resilient city across vital areas such as energy, natural resources, transportation, waste, and economic development.



Age-Friendly Albuquerque Action Plan seeks to enhance community engagement, foster connections, and increase access to age-friendly resources and practices in Albuquerque.



Community Planning Area Assessments: Community Planning Areas were adopted as the City's new long range planning model during the 2017 Comprehensive Plan. The CPA assessment process seeks to develop positive relationships between the City and community members by focusing on actions that can lead to transformative changes in the community. Since 2021, planning staff has completed the following three assessments:

- **Near Heights CPA** - Key themes include access to local institutions and businesses, preservation of historical and community character in built areas, celebration of diverse cultures, and promotion of pedestrian-friendly development.
- **SW Mesa CPA** - Enhance community-city ties, infrastructure improvements and growth. covering economic development efforts, business registrations, housing metrics and affordability, park and open space metrics, and potentially heritage conservation.
- **Central CPA** - Key themes that have emerged out of the ongoing Central CPA engagement are walkable environments, environmental cumulative impacts, investment in our historic and vulnerable neighborhoods and a focus on economic growth in Central Albuquerque.

EDUCATION FOR EMPOWERMENT: YOUR ROLE IN ALBUQUERQUE'S SUCCESS

Our update serves as an educational tool for our community members and a lasting resource for our City staff to measure our progress over the last six years and ensure that the city remains aligned with the goals and vision set in 2017. No new policies or actions are being recommended outside of the above reports, due to each report's intensive community engagement.
